

Cranbrook Permission Slip

On Tuesday, September 30, the fifth graders will be given the chance to explore Cranbrook Science Center. This is a fabulous trip that ties our 5th grade science and social studies learning goals together. It especially focuses on our current science unit, Objects in the Sky, with a visit to the planetarium for a show on moon phases and season changes. We will travel by bus, leaving school at approximately 8:50 AM and returning at approximately 2:00 PM.

Students will need to bring their own paper bag lunch (please, disposable containers only - no glass!). PLEASE HAVE YOUR CHILD WRITE THEIR NAME ON THE PAPER BAG! Students may want to bring money with them as there is also a gift shop; however, it will be up to their chaperone whether or not they participate in these activities.

Please return the permission slip and \$15.00 by Friday, September 26. This will cover the cost of the visit to the science museum, planetarium show, travelling exhibit, and the school busses. Students may not participate in any field trip without a signed permission slip on file. If you need assistance paying for the trip, please send in a note with your child's permission slip - no child will be left behind due to financial difficulty.

Chaperones are needed to lead children through the museum to the required destinations on the schedule of events. There is no cost for chaperones to attend the trip, BUT WE ARE LIMITED TO 10 PEOPLE.
